

**PRELIMINARY FINDINGS OF FACT**  
Renewal of Surface Coal Mining Permit S-0606

The Alaska Department of Natural Resources, Division of Mining, Land and Water (DMLW-mining) has reviewed the Jumbo Dome Mine renewal application, submitted by Usibelli Coal Mine, Inc. (UCM), PO Box 1000, Healy, AK 99743. The DMLW-Mining found the renewal application to be consistent with AS 27.21 and 11 AAC 90 and makes the following Preliminary Findings of Fact and Decision.

1. A request to renew Surface Coal Mining Permit S-0606 was filed with the DMLW-Mining on May 27, 2016. Renewal of the permits has been requested in accordance with AS 27.21.080(d) and 11 AAC 90.129(b).
2. The Jumbo Dome Mine is located on State Land approximately 90 miles south of Fairbanks, Alaska, and 9 miles northeast of Healy, Alaska. The Jumbo Dome Mine permit area consists of approximately 3,237.7 acres of which 1098.7 will be disturbed over the 27-year mine life. The mine is located within: Sections 27, 28, 33, and 34, Township 10 South, Range 6 West, and Sections 3-5, 8, and 9, Township 11 South, Range 6 West, Fairbanks Meridian. The area can be found on the Fairbanks A4 and Healy D4 Quad maps.
3. The renewal request contains all the information required and is sufficient for this office to make a decision.
4. This renewal request is for an additional five-year term and includes the permit areas previously approved in the existing permits. No revisions have been requested as part of this permit renewal. The originally approved permits meet the requirements of AS 27.21 and 11 AAC 90 subject to the stipulations of the original permits, which are revised to ensure that the surface coal mining and reclamation operations will comply with these requirements.
5. Public notice of this permit renewal application will be for the period starting on January 17, 2017 and ending on March 8, 2017. Legal ads will be placed in the Fairbanks Daily News Miner starting on January 17, 2017, and will be noticed for four consecutive weeks. Notice was mailed directly to the Division's mailing list of 36 affected and interested persons and agencies.
6. This renewal does not change the scope or the environmental impacts of the project. The activities proposed in the renewal do not differ from the originally approved permits and meet the requirements of AS 27.21 and 11 AAC 90 subject to the stipulations of the original permits, which ensure that the surface coal mining reclamation and operation plan comply with these requirements.
7. Pursuant to 11 AAC 90.205(d) the DMLW-Mining has determined that a reclamation bond in the amount of \$3,815,314.00 is sufficient to guarantee the present obligations under these permits. The bond is conditioned upon the completion of the required reclamation and compliance with all terms, stipulations, and conditions of the original permits and this renewal.
8. Any changes to the approved activities will require approval and modification of the posted reclamation bond.

9. The permit areas have not changed and are not within an area designated unsuitable for mining under AS 27.21.260.
10. The proposed surface coal mining reclamation and operation plan will not affect known threatened or endangered species or their critical habitat.
